

## Request for Proposals:

The Sisseton Wahpeton Oyate Tribal Opioid Response Key Informant Interview Consultant regarding the impact of Opioid Use Disorders (OUD), Community Health Worker (CHW) Services, Medication for Opioid Use Disorders (MOUD) and other Recovery Support Services with Tribal Opioid Response participants.

### Scope of Work:

1. Review Tribal Opioid Response Program's (TOR) existing Community Readiness Assessment Data on MOUD perceptions and Key Informant Interviews.
2. Meet with the Tribal Opioid Response Program (TOR) staff at Asniyapi Clinic to discuss existing data: community readiness surveys and prior key informant interviews, and other information that will be beneficial through key informant interviews with TOR participants.
3. Develop interview type, key informant population and choice (#), interview tool (questions), schedule, logistics, and documentation methods.
4. Conduct interviews according to schedule and plan.
5. Compile data in accordance with documentation methods and draft the report of findings.
6. Present draft report and debrief with the Tribal Opioid Response Program team members.
7. Provide a final written Key Informant Interview Report.

Evaluation Process will be conducted using the following criteria:

1. Price (30 points)
2. Qualifications and Experience (30 points)
3. Capacity to Perform (30 points)
4. Indian Preference (10 points)

All proposals must include:

1. Applicant's contact information (name, address, telephone number, email address)
2. Brief description and history of the applicant's quantifications and experience performing similar work.
3. Statement of capacity to perform the scope of work, including recent, current and future commitments that could conflict with or affect the applicant's ability to complete the project on or before June 30<sup>th</sup>, 2026.

4. Estimated cost of all work, materials, fees and reimbursable expenses required to perform scope of work deliverables (note to exceed the project budget of \$3,000)
5. Copy of SWO Business License
6. Completed W-9 Form and other IRS documentation
7. Tribal Tax – 5.5%
8. Liability Insurance
9. Workman's Comp (if required)
