The Sisseton Wahpeton Oyate is seeking a a qualified contractor for a water development project.

**Scope of work:** The intent of this Request for Proposal (RFP) is for the purpose of selecting a qualified contractor to provide personnel, equipment, and supplies necessary for a water development project in Spring Grove Township. The water development project must be signed off by a certified well driller as project is contracted as supplemental well with solar pump capable of supplying 15-20 gal per min of water to 10,000 gal storage tank at an elevation of 100 ft above bottom of well pit.

Work to be completed will be the removal of an existing culvert into a spring and install a slotted 30 in, 20-foot ribbed poly double wall culvert or a galvanized culvert. Area around culvert will be back sloped approx. 30 feet and back filled with 3/4% to 1 inch rock from local pits (based on need approx. 130 ton). Test pumping and developing the installed piping with a complete 24 hr. pump test incl. recovery. Cap will be installed on culvert base and top cemented with access for installation of sleeves for piping. Installation of Grundfos or equivalent solar pump and approximately (6) - 200 watt solar panels to pump 6,000 gal of water per day, panel support system, 3-phase disconnect switch and wiring to pump, well pressure tank and switch control
