- 09-01-01 **SHORT TITLE**
This Chapter shall be known and may be cited as the Sisseton-Wahpeton Sioux Nonprofit Corporations Ordinance.
- 09-02-01 **DEFINITIONS**
As used in this Ordinance, the terms:
- 09-02-02 Corporation or Domestic Corporation - means a corporation not for profit subject to the provisions of this Ordinance.
- 09-02-03 Not for Profit Corporation - means a corporation no part of the income of which is distributable to its members, directors, or officers; except nothing in this Chapter shall be construed as prohibiting the payment of reasonable compensation for services rendered and the making of distribution upon dissolution or final liquidation as permitted in this Chapter.
- 09-02-04 Article of Incorporation - means the original articles of incorporation and all amendments thereto, including articles of merger of consolidation, and in the case of a corporation created by a special ordinance or resolutions of the Tribal Council, means such special ordinance or resolution and any amendments thereto.
- 09-02-05 By-laws - means the Code of Codes of Rules adopted for the regulation or management of the affairs of a corporation irrespective of the names or names by which such rules are designated.
- 09-02-06 Member - means one having membership rights in a corporation in accordance with the provisions of its articles of incorporation or by-laws.
- 09-02-07 Board of Directors - means the group of persons vested with the management of the affairs of a corporation irrespective of the names by which such group is designated.
- 09-02-08 Insolvent - means that a corporation is unable to pay its debts as they become due in the usual course of its affairs.
- 09-02-09 Treasurer - means the Tribal Treasurer or the agent or agents designated by him to perform any function vested in the Treasurer by this Ordinance.
- 09-02-10 Reservation - means the Lake Traverse Reservation.

09-02-11 The Court - means except where otherwise specified, the Sisseton-Wahpeton Sioux Tribal Court.

09-03-01 **APPLICABILITY**

The provisions of this Ordinance shall apply to all corporations organized hereunder or which elect to accept the provisions of this Chapter.

09-04-01 **PURPOSE**

Corporations may be organized under this Chapter for any lawful purpose or purposes including, but not limited to, one or more of the following purposes: benevolent; religious; missionary; musical; social; athletic; patriotic; political; civil; professional; commercial; industrial; business; or trade association; mutual improvement; promotion of the Arts.

09-05-01 **GENERAL POWERS**

Each corporation shall have the power:

1. To have perpetual succession by its corporate name unless a limited period of duration is stated in its articles of incorporation;
2. To sue and be sued, complain and defend, in its corporate name;
3. to have a corporate seal which may be altered at pleasure and to use the same by causing it, or a facsimile thereof, to be impressed or affixed in any other manner reproduced;
4. To purchase, take, receive, lease, take by gift or bequest or otherwise acquire, own, hold, improve, use, and otherwise deal in and with, real or personal property, or any interest therein, wherever situated;
5. To sell, convey, mortgage, pledge, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;
6. to lend money to and otherwise assist its employees other than its officers and directors;
7. To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, loan, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, whether or not incorporated under this Ordinance and whether for profit or not for profit, associations, partnerships, or individuals, or direct or indirect obligations of the United States, or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof or any familiar tribe;

8. To make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise and income;
9. To lend money for its corporate purposes, invest and reinvest into funds, and take and hold real and personal property as security for the payment of funds so loaned or invested;
10. To conduct its affairs, carry on its operations, hold property, and have offices and exercise the powers granted by this Ordinance;
11. To elect or appoint officers and agents of the corporation, and define their duties and fix their compensation;
12. To make and alter by-laws, not inconsistent with its articles of incorporation or with the laws, ordinances, and regulations of the Sisseton-Wahpeton Sioux Tribe and the United States, for the administration and regulation of the affairs of the corporation; and
13. Unless otherwise provided in the articles of incorporation, to make donations for the public welfare or for religious, charitable, scientific research, or educational purposes, or for other purposes for which the corporation is organized.

09-06-01 DEFENSE OF ULTRA VIRES

No act of a corporation and no conveyance or transfer of real or personal property to or by a corporation shall be invalid by reason of the fact that the corporation was without capacity or power to do such act or to make or receive such conveyance or transfer, but such lack of capacity or power may be asserted:

1. In a proceeding by a member or a director against the corporation to enjoin the doing of any act, or the transfer of real or personal property by or to the corporation. If the act or transfer sought to be enjoined is being, or is to be, performed pursuant to any contract to which the corporation is a party, the Court may, if all of the parties to the contract are parties to the proceedings and if it deems the same to be equitable, set aside and enjoin the performance of such contract, as the case may be, compensation for the loss or damages sustained by either of them which may result from the action of the Court in setting aside and enjoining the performance of such contract, but anticipated profits to be derived from the performance of the contract shall not be awarded by the Court as a loss or damages sustained.

2. In a proceeding by the corporation, whether acting directly or through a receiver, trustee, or other legal representative, or through members in a representative suit, against the incumbent or former officers or trustee of the corporation; and
3. In a proceeding by the Tribal Treasurer as provided in this Chapter, to dissolve the corporation or in a proceeding by the Tribal Treasurer to enjoin the corporation from the transaction of authorized acts.

09-07-01 CORPORATE NAME

The Corporate Name:

1. Shall not contain any word or phrase which indicates or implies that it is organized for any purpose other than one or more of the purposes contained in its articles of incorporation; and
2. Shall not be the same as, or deceptively similar to the name of any corporation, whether for profit or not for profit organized under this Ordinance or any other Ordinance or resolution of the Tribe to transact business or conduct affairs in the Reservation.

09-08-01 REGISTERED OFFICE AND REGISTERED AGENT

Each corporation shall have and continuously maintain on this Reservation.

1. A registered office; and
2. A registered agent.

09-09-01 REGISTERED AGENT AS AN AGENT FOR SERVICE

09-09-02 The registered agent appointed by a corporation as provided in this Ordinance shall be an agent of such corporation upon whom a process, notice, or demand required or permitted by law to be served upon the corporation may be served.

09-09-03 Whenever a corporation shall fail to appoint or maintain a registered agent in this Reservation or whenever its registered agent cannot, with reasonable diligence, be found at the registered office, then the Tribal Treasurer shall be an agent of such corporation upon whom any such process, notice, or demand shall be made by delivering to and leaving with them, or with any clerk having charge of their office, duplicate copies of such process, notice or demand. In the event that any such process, notice or demand is served on the Tribal Treasurer, he shall immediately cause one of such copies thereof to be forwarded by registered or certified mail, addressed to the corporation at its registered office.

- 09-09-04** The Tribal Treasurer shall keep a record of all processes, notices, and demands served upon them under this Section, and shall keep a record therein of the time of such service and their action with respect thereto.
- 09-09-05** Nothing herein contained shall limit or affect the right to serve any process, notice or demand required or permitted by law to be served upon a corporation in any other manner now or hereafter permitted by law.
- 09-10-01 MEMBERS**
A corporation may have members or may have no members. If the corporation has members, the manner of election or appointment and the qualifications and rights of the members shall be set forth in the articles of incorporation or the by-laws. If the corporation has no members, that fact shall be set forth in the articles of incorporation. A corporation may issue certificates evidencing membership therein.
- 09-11-01 BY-LAWS**
The initial by-laws of a corporation shall be adopted by its Board of Directors. The power to alter, amend, or repeal the by-laws or adopt new by-laws shall be vested in the Board of Directors unless otherwise provided in the articles of incorporation or the by-laws.
- 09-12-01 MEETINGS OF MEMBERS**
- 09-12-02** Meetings of members may be held at such place within or without the Reservation as may be provided in the by-laws or, where not inconsistent with the by-laws, in the notice of the meeting.
- 09-12-03** An annual meeting of the members shall be held at such time as may be provided in the by-laws. Failure to hold the annual meeting at the designated time shall not work a forfeiture of dissolution of the corporation.
- 09-12-04** Special meetings of the members may be called by the president, the secretary, the Board of Directors, or by such other officers or persons or number or proportion of members as may be provided in the articles of incorporation or the by-laws. In the absence of a provision fixing the number or proportion of members entitled to call a meeting, a special meeting having at least one-twentieth (1/20) of the votes to be cast at such meeting.
- 09-13-01 NOTICE OF MEMBERS MEETING**
Written or printed notice stating the place, day and hour of the meeting, and, in case of a special meeting, the purpose or purposes for which the meeting is called, shall in the absence for a provision in the by-laws specifying a different period of notice, be delivered not less than ten (10) or more than fifty (50) days before the date of the meeting, either personally or by mail; or at the direction of the president.

or the secretary of the officers of persons calling the meeting, to each member entitled to vote at such meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the member at this address as it appears on the records of the corporation, with postage thereon prepaid.

09-14-01 VOTING

09-14-02 Members shall not be entitled to vote except as the right to vote shall be conferred by the articles of incorporation.

09-14-03 A member may vote in person, or unless the articles of incorporation or the by-laws otherwise provide, may vote by proxy executed in writing by the member or his duly authorized attorney-in-fact. No proxy shall be valid after eleven (11) months from the date of its execution, unless otherwise provided in the proxy. Where the articles of incorporation or the by-laws so provide, voting on all matters including the election of directors or officers where they are to be elected by the members, may be conducted by mail.

09-14-04 The articles of incorporation or the by-laws may provide that in all elections for directors every member entitled to vote shall have the right to cumulate his vote and to give one candidate a number of votes equal to his vote multiplied by the number of directors to be elected or by distributing such votes on the same principle among any number of such candidates.

09-14-05 If a corporation has no members or if the members have no right to vote, the directors shall have the sole voting power and shall have all of the authority and may take any action herein permitted by members.

09-15-01 QUORUM

09-15-02 The by-laws may provide the number or percentage of members entitled to vote represented in person or by proxy, or the number or percentage of votes represented in person or by proxy, which shall constitute a quorum at a meeting of members. In the absence of any such provisions, members having at least one-tenth (1/10) of the votes entitled to be cast represented in person or by proxy shall constitute a quorum. The affirmative vote of a majority of the votes entitled to be cast by the members present or represented by proxy at a meeting at which a quorum is present, shall necessary for the adoption of any matter voted upon by the members, unless a greater proportion is required by this Ordinance, the articles of incorporation or the by-laws.

09-15-03 Unless, otherwise provided by the articles of incorporation or the by-laws, the members present at a duly organized meeting may continue to do business until adjournment notwithstanding the withdrawal of enough members to leave less than a quorum.

- 09-15-04** If a meeting cannot be organized because a quorum has not attended, those present may adjourn the meeting from time to time until a quorum is present, when any business may be transacted that may have been transacted at the meeting as originally called.
- 09-16-01 BOARD OF DIRECTORS**
The affairs of a corporation shall be managed by a Board of Directors. Directors need not be residents of the Reservation or members of the corporation unless the articles of incorporation or the by-laws may prescribe other qualifications for directors.
- 09-17-01 NUMBER, ELECTION, CLASSIFICATION AND REMOVAL OF DIRECTORS**
- 09-17-02** The number of directors of a corporation shall be not less than three. Subject to such limitation, the number of directors shall be fixed by the by-laws, except as to the number of the first Board of Directors, which number shall be fixed by the article of incorporation. The number of directors may be increased or decreased from time to time by amendment to the by-laws, unless the articles of incorporation provide that a change in the number of directors shall be made only by amendment of the articles of incorporation. No decrease in number shall have the effect of shortening the term of any incumbent director. In the absence of a by-law fixing the number of the directors, the number shall be the same as that stated in the articles of incorporation.
- 09-17-03** The names and addresses of the members of the first Board of Directors shall be stated in the articles of incorporation. Such persons shall hold office until the first annual election of directors or for such period as may be specified in the articles of incorporation or the by-laws. Thereafter, directors shall be elected or appointed in the manner and for the terms of office, the term of office of a director shall be one (1) year.
- 09-17-04** Directors may be divided into classes and the terms of office of the several classes need not be uniform. Each director shall hold office for the term for which he is elected or appointed and qualified, except in the case of ex officio directors.
- 09-17-05** A director may be removed from office pursuant to any procedure therefor provided in the articles of incorporation or the by-laws, and if none be provided, may be removed at a meeting called expressly for that purpose, with or without cause, by such vote as would suffice for his election.
- 09-18-01 VACANCIES**
Any vacancy occurring in the Board of Directors and any directorship to be filled by reason of an increase in the number of directors may be filled by the affirmative vote of a majority of the then members of the Board of Directors,

though less than a quorum of the board, unless the articles of incorporation or the by-laws provide that a vacancy or directorship so created shall be filled in some other manner, in which case such provision shall control. A director elected or appointed, as the case may be, to fill a vacancy shall be elected or appointed for the unexpired term of his predecessor in office.

09-19-01 QUORUM OF DIRECTOR

A majority of the number of directors fixed by the by-laws, or in the absence of a by-law fixing the number of directors, then of the number stated in the articles of incorporation, shall constitute a quorum for the transaction, shall constitute a quorum for the transaction of business, unless otherwise provided in the articles of incorporation, or the by-laws, but in no event shall a quorum consist of less than one-third (1/3) of the number of directors so stated or fixed. The act of the majority of the directors present at a meeting at which a quorum is present shall be the act of a greater number is required by this Chapter or by the articles of incorporation or the by-laws.

09-20-01 COMMITTEES

If the articles of incorporation or the by-laws so provide, the Board of Directors, by resolution adopted by a majority of the directors in the office, may designate and appoint one or more committees, each of which shall consist of two or more directors, which committees, to the extent provided in said resolution, in the articles of incorporation or in the by-laws of the corporation, shall have and exercise the authority of the Board of Directors in the management of the corporation. Other committees not having and exercising the authority of the Board of Directors in the management of the corporation may be designated and appointed by a resolution adopted by a majority of the directors present at a meeting at which a quorum is present. The designation and appointment of any such committee and the delegation thereto of authority shall not operate to relieve the Board of Directors, or any individual director, of any responsibility imposed upon it or him by law.

09-21-01 PLACE AND NOTICE OF DIRECTORS' MEETINGS

Meeting of the Board of Directors, regular or special, may be held at such place within or without the Reservation, and upon such notice as may be prescribed by the by-laws, or where not inconsistent with the by-laws, by resolution of the Board of Directors. A director's attendance at any meeting shall constitute a waiver of notice of such meeting, excepting such attendance at a meeting by the director for the purpose of objecting to the transaction of business because the meeting is not lawfully called or convened. Neither the business to be transacted, nor the purpose of, any regular or special meeting of the Board of Directors need be specified in the notice or waiver of such notice, of such meeting, unless otherwise provided in the articles of incorporation or the by-laws.

09-22-01 OFFICERS

09-22-02 The officers of a corporation shall consist of a president, a secretary, and a treasurer, and may include one or more vice-presidents, and such other officers and assistant officers as may be deemed necessary, each of whom shall be elected or appointed at such time and in such manner and for such terms not exceeding three (3) years as may be prescribed in the articles of incorporation or the by-laws. In the absence of any such provision, all officers shall be elected or appointed annually by the Board of Directors. If the by-laws so provided, any two or more offices may be held by the same person, except the offices of president and secretary.

09-22-03 The articles of incorporation or the by-laws may provide that any one or more officers of the corporation or other organizations shall be ex officio members of the Board of Directors.

09-22-04 The officers of a corporation may be designated by such other titles as may be provided in the articles of incorporation or the by-laws.

09-22-05 All officers and agents of the corporation, as between themselves and the corporation, shall have such authority and perform such duties in the management of the property and affairs of the corporation as may be provided in the by-laws, or as may be determined by resolution of the Board of Directors not inconsistent with the by-laws.

09-23-01 REMOVAL OF OFFICERS

Any officer or agent elected or appointed may be removed by the persons authorized to elect or appoint such officer or agent whenever, in their judgement, the best interest of the corporation will be served thereby, but such removal shall be without prejudice to the contract right, if any, of the person so removed. Election or appointment of an officer or agent shall not in itself create contract rights.

09-24-01 BOOKS AND RECORDS

Each corporation shall keep correct and complete books and records of account and shall keep minutes of the proceedings of its members, Board of Directors, and committees having any of the authority of the Board of Directors; and shall keep at its registered office or principle office on the Reservation, a record of the names and addresses of its members entitled to vote. All books and records of a corporation may be inspected by any member having voting rights, or his agent or attorney for any proper purpose at any reasonable time.

09-25-01 SHARES OF STOCK AND DIVIDENDS PROHIBITED

A corporation shall not authorize or issue shares of stock. No dividend shall be paid and no part of the income of a corporation shall be distributed to its members, directors, or officers. A corporation may pay compensation, including

pensions, in a reasonable amount to its members, directors, or officers for services rendered, may confer benefits upon its members in conformity with its purposes, and upon dissolution or final liquidation, may make distribution to its members or others as permitted by this Chapter.

09-26-01 LOANS TO DIRECTORS AND OFFICERS PROHIBITED

No loans shall be made by a corporation to its directors or officers. The directors of a corporation who vote for or assent to the making of a loan to a director or an officer of the corporation, and any officer participating in the making of such a loan, shall be jointly and severally liable to the corporation for the amount of such loan until the repayment thereof.

09-27-01 INCORPORATION

Three (3) or more natural persons of the age of twenty-one (21) years or more may act as incorporators of a corporation by signing, certifying, and delivering in duplicate to the Tribal Treasurer, articles of incorporation for such corporation.

09-28-01 ARTICLES OF INCORPORATION

09-28-02 The articles of incorporation shall be set forth:

1. The name of the corporation;
2. The period of duration, which may be perpetual;
3. The purpose or purposes for which the corporation organized;
4. If the corporation is to have no members, a statement to that effect;
5. If the corporation is to have members, any provision which the incorporators elect to set forth in the articles of incorporation stating the qualifications and rights of members and conferring, limiting, or denying the right to vote;
6. If the directors or any of them are not to be elected or appointed by members, a statement of the manner in which such directors shall be elected or appointed, or that the manner of such election or appointment of such directors shall be provided in the by-laws;

7. Any provisions, not inconsistent with this Ordinance or any other law or ordinance of the Sisseton-Wahpeton Sioux Tribe which the incorporators elect to set forth in the articles of incorporation for the regulation of the internal affairs of the corporation, including any provision for distribution of assets on dissolution or final liquidation and any provisions whir under this Chapter is required or permitted to be set forth in the by-laws;
8. The address, including street and number, if any, of its initial registered office, and name of its initial registered agent at such address;
9. The number of directors constituting the initial board of directors, and the names and addresses, including street and number, if any, of the persons who are to serve as the initial directors until the first annual meeting or until their successors be elected and qualify; and,
10. The name and address, including street and number, if any, of each incorporator.

09-28-03 It shall not be necessary to set forth in the articles of incorporation any of the corporate powers enumerated in this Chapter.

09-28-04 Unless the articles of incorporation provide that a change in the number of directors shall be made only by amendment to the articles of incorporation, a change in the number of directors made by amendment to they by-laws shall be controlling. Whenever a provision of the articles of incorporation is inconsistent with a by-law, the provision of the articles of incorporation shall be controlling.

09-29-01 FILING OF ARTICLES OF INCORPORATION

09-29-02 Duplicate originals of the articles of incorporation shall be delivered to the Tribal Treasurer.

09-29-03 If the Tribal Treasurer finds that the articles of incorporation conform to law, they shall, when all fees charges have been paid as in this Chapter prescribed:

1. Endorse on each of such duplicate originals the word "Filed" and the month, day, and year of filing thereof;
2. File one of such duplicate originals in their office;
3. Issue a certificate of incorporation to which they shall affix the other duplicate original; and

4. Deliver the certificate of incorporation, together with the duplicate original of the articles of incorporation affixed thereto, to the incorporators or their representative.

09-30-01 EFFECT OF ISSUANCE OF CERTIFICATE OF INCORPORATION

Upon the incorporation, the corporate existence shall begin, and such certificate of incorporation shall be conclusive evidence that all conditions precedent required to be performed by the corporation have been complied with and that the corporation has been incorporated under this Chapter, except as against the Sisseton-Wahpeton Sioux Tribe in a proceeding to cancel or revoke the certificate of incorporation.

09-31-01 ORGANIZATION MEETING

09-31-02 After the issuance of the certificate of incorporation, an organization meeting of the Board of Directors named in the articles of incorporation shall be held within the Reservation at the call of a majority of the directors so named for the purpose of adopting by-laws, (unless the power to adopt by-laws has been reserved by the articles of incorporation to the members, in which event the by-laws shall be adopted by the members), electing officers, and the transaction of such other business as may come before the meeting. The directors calling the meeting shall give at least five (5) days notice thereof by mail to each director so named; which notice shall state the time and place of the meeting; provided, however, that if all the directors shall waive notice in writing and fix a time and place for said organization meeting, no notice shall be required for such meeting.

09-31-03 A first meeting of the members may be held at the call of the directors, or a majority of them, upon at least five (5) days notice, for such purposes as shall be stated in the notice of the meeting.

09-32-01 RIGHT TO AMEND ARTICLES OF INCORPORATION

A corporation may amend its articles of incorporation, from time to time, in any and as many respects as may be desired; provided that its articles of incorporation as amended contain only such provisions as might be lawfully contained in original articles of incorporation if made at the time of making such amendment.

09-33-01 PROCEDURE TO AMEND ARTICLES OF INCORPORATION

Amendments to the articles of incorporation shall be made in the following manner:

09-33-02 Where there are members having voting rights, the Board of Directors shall adopt a resolution setting forth the proposed amendment and directing that it is to be submitted to a vote at a meeting of members having voting rights, which may be either an annual or a special meeting;

09-33-03 Written or printed notice setting forth the proposed amendment or a summary of the changes to be affected thereby shall be given to each member entitled to vote at such meeting within the time and in the manner provided in this Chapter for the giving of notice of meetings of members. If the meeting be an annual meeting, the proposed amendment or such summary shall be included in the notice of such annual meeting;

09-33-04 The proposed amendment shall be adopted upon receiving the affirmative vote of at least two-thirds (2/3) of the votes entitled to be cast by members present or represented by proxy at such meeting;

09-33-05 Where there are no members, or no members having voting rights, an amendment shall be adopted at a meeting of the Board of Directors upon receiving the vote of a majority of the Directors in office; and

09-33-06 Any number of amendments may be submitted and voted upon at any one meeting.

09-34-01 **ARTICLES OF AMENDMENT**

The articles of amendment shall be executed in duplicate by the corporation; by its president or a vice-president, and the corporate seal shall be thereto affixed, attested by its secretary or an assistant secretary, and shall set forth:

1. The name of the corporation;
2. The amendment so adopted;
3. Where there are members having voting rights;
 - a. A statement setting forth the date of the meeting of members at which the amendment was adopted, that a quorum was present at such meeting, and that such amendment received at least two-thirds (2/3) of the votes entitled to be cast by members present or represented by proxy at such meeting; or
 - b. A statement that such amendment was adopted by a consent in writing signed by all members entitled to vote with respect thereto;
4. Where there are no members, or no members having voting rights, a statement of such fact, the date of the meeting of the Board of Directors at which the amendment was adopted, and a statement of the fact that such amendment received the vote of a majority of the directors in office.

A resolution to dissolve the corporation shall be adopted upon receiving at least two-thirds (2/3) of the votes entitled to be cast by members present or represented by proxy at such meeting;

2. Where there are no members, or no members having voting rights, the dissolution of the corporation shall be authorized at a meeting of the Board of Directors upon the adoption of a resolution to dissolve by the vote of a majority of the directors in office; and

Upon adoption of such resolution by the members, or by the Board of Directors where there are no members or members with voting rights, the corporation shall cease to conduct its affairs except insofar as may be necessary for the winding up thereof; shall immediately cause a notice of the proposed dissolution to be mailed to each known creditor of the corporation and shall proceed to collect its assets and apply and distribute them as provided in this Chapter.

The assets of a corporation in the process of dissolution shall be applied and distributed as follows:

Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the by-laws to the extent that the articles of incorporation or by-laws determine the distributive rights of members, or any class of classes of members, or provide for distribution to others; and
5. Any remaining assets may be distributed to such persons, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, as may be specified if a plan of distribution is adopted as provided in this Chapter.

09-39-01 PLAN FOR DISTRIBUTION

A plan providing for the distribution of assets, not inconsistent with the provisions of this Chapter, may be adopted by a corporation in the process of dissolution and shall be adopted by a corporation for the purpose of authorizing any transfer or conveyance of assets for which this Chapter requires a plan for distribution, in the following manner:

1. Where there are members having voting rights the Board of Directors shall adopt a resolution recommending a plan of distribution and directing that the plan be submitted to a vote at a meeting of members having boeing rights, which may be either an annual meeting or a special meeting. Written or printed notice setting forth the proposed plan of distribution or a summary thereof shall be given to each member entitled to vote at such meeting, within the time and in the manner provided in this Chapter for the giving of notice of meetings of members. Such plan of distribution shall be adopted upon receiving at least two-thirds (2/3) of the votes entitled to be cast by members present or represented by proxy at such meeting; and
2. Where there are no members, or no members having voting rights, a plan of distribution shall be adopted at a meeting of the Board of Directors upon receiving the vote of a majority of the directors in office.

09-40-01 REVOCATION OF VOLUNTARY DISSOLUTION PROCEEDINGS

A corporation may, at any time prior to the issuance of a certificate of dissolution by the Tribal Treasurer as hereinafter provided, revoke the action theretofore taken to dissolve the corporation in the following manner:

1. Where there are members having voting rights, the Board of Directors shall adopt a resolution recommending that the voluntary dissolution proceedings be revoked, and directing that the question of such revocation be submitted to a vote at the meeting of members having voting rights, which may be either an annual or a special meeting. 09-45-01 **PROCEDURE IN LIQUIDATION OF CORPORATION BY COURT**

09-45-02 In proceedings to liquidate the assets and affairs of a corporation, the Court shall have the power to issue injunctions, to appoint receivers pendente lite, with such powers and duties as the Court, from time to time may direct, and to take such other proceedings as may be requisite to preserve the corporate assets wherever situated, and carry on its affairs of the corporation until a full hearing can be had.

Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution or liquidation, shall be transferred or conveyed to one or more domestic or foreign corporations, societies, or organizations engaged in activities substantially similar to those of the dissolving or liquidating corporation as the Court may direct;
4. Other assets, if any, shall be distributed in accordance with the provisions of the articles of incorporation or the by-laws to the extent that the articles of incorporation or by-laws determine the distributive rights of the members or any class or classes of members, or provide for distribution to others; and
5. Any remaining assets may be distributed to such persons, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, specified in the plan of distribution adopted as provided in this Chapter, or where no plan of distribution has been adopted, as the Court may direct.

09-45-05 The Court shall have power to allow, from time to time, as expenses of the liquidation, compensation to the receiver or receivers and to attorneys in the proceeding, and to direct the payment thereof out of the assets of the corporation or the proceeds of any sale or disposition of such assets.

Each corporation, foreign or domestic, that fails or refuses to file its annual report for any year within the time prescribed by this Chapter shall be subject to a penalty of five dollars (\$5.00), to be assessed by the Tribal Treasurer.

09-56-01 FEES FOR FILING DOCUMENTS AND ISSUING CERTIFICATES

The Tribal Treasurer shall charge and collect for:

1. Filing articles of incorporation and issuing a certificate of incorporation;
2. Filing articles of amendment and issuing a certificate of amendment;
3. Filing a statement of change of address of registered office or change of registered agent, or both;
4. Filing articles of dissolution;
5. Filing a statement of election to accept this Chapter and issuing certificate of acceptance;

8. Furnishing a certified copy of any document, instrument, or paper relating to a corporation;

09-58-01 FORMS TO BE FURNISHED BY THE TRIBAL TREASURER

All reports required by this Ordinance to be filed in the office of the Tribal Treasurer shall be made on forms which shall be prescribed and furnished by the Tribal Treasurer. Forms for all other documents to be filed in the office of the Tribal Treasurer on request therefor, but the use thereof, unless otherwise specifically prescribed in this Chapter, shall not be mandatory.

09-59-01 GREATER VOTING REQUIREMENTS

Whenever, with respect to any action to be taken by the members or directors of a corporation, the articles of incorporation requires the vote or concurrence of a greater proportion of the members or directors, as the case may be, than required by this Ordinance, with respect to such action, the provisions of the articles of incorporation shall control.
