This RFQ is a short-form qualification process, not a request for a detailed proposal, to establish a pool of firms for various services, including architectural and engineering support, environmental assessments, economic diversification, community engagement, and more. Firms will be contacted as needs arise, and may be tasked to review applications/proposals or prepare plans and studies that require expertise beyond that possessed by the department's existing staff or existing staffing levels are inadequate to accommodate the workload attributed to specified projects, with no guarantee of minimum amount of work.
